- Any other.



- The contents of the syllabi of two Semesters along with the References could be **revised** and finalized. Altogether five papers of first semester and four papers of third Semester were completed, as the new academic year shall have 1st and the 3rd Semesters to be taught as soon as it resumes. Due to paucity of time the committee could not take up the other papers. Following are the titles of the papers- (placed alongside)
- M.A 1st year course Papers- 1.Introduction to Women Studies.2.Feminism and Feminist Theories.3.Women's Status in India.4. Fundamentals of Information and Technology.5.Research Methodology in Women's Studies.
- M.A 3rd Year Course Papers- 1.Women and Law.2. Women and Media. 3. Women and Religion.4.Women and Environment.
- The committee strongly feel the need to re-Christian the name of the dept. and it is suggested that the Dept. name and the Courses offered should be in synch; hence it is unanimously recommend proposing that the Dept. should be re-named as "**Dept. of Women's Studies**".

- It is resolved that the Dept. of Women Education should work along with the local NGOs to identify the women's issues and conduct empirical survey. As it is felt that this will provide a wider scope for students coming from various parts of the country acclimatize with local populace and facilitate a smooth conduct of survey and also to help in placements.
- Due to the unfortunate demise of Prof. Rehana Sultana, the students working under her guidance required being **re-located**; as such the DRC had reallocated the guides for M.Phil and PhD students. . Also the topics and Guides for the Academic Year 2014-15. The committee has resolved to approve the minutes of the DRCs in this regard.
- A list of new members have been prepared to be included as **examiners** in the existing list, the committee recommends it.
- Two PhD students viz; Ms. Azeezunnisa and Ms. Azema Sadath Sultana of October 2009 batch (Regular) have requested for extension of six months from April 26th to October 2015. The same has been recommended.
