CWS Advisory Committee meeting was held on 28/09/2016 on 11:30am in Conference Hall of Administrative Building, MANUU.

Dr. Mohd. Aslam Parvaiz, Hon'ble Vice Chancellor, MANUU & the Chairperson of the CWS-Advisory Committee was engaged with another schedule. In his absence, Dr. Shakeel Ahmed, Registrar, MANUU, chaired the meeting.

At the beginning, Chairperson of the Advisory Committee welcomed all the members and thanked them for their acceptance to attend the meeting.

- 1) Dr. Aameena Tahseen, Director, CWS & Member, Convener, started the discussion by giving PowerPoint presentation on Introduction of CWS and the details of activities completed from April 2012-March 2016.
- 2) As such, most of the activities completed during January 2015 to March 2016, the committee members expressed their satisfaction and appreciated the works and initiatives taken up by the CWS with very limited resources within the short span of time.
- 3) The Member, Convener, informed the members regarding the current status of CWS. The UGC placed the Centre in Phase-1 and issued the continuation letter and sanction of financial assistance for 12th plan period.
- 4) The Member, Convener, presented the Plan of Action for the year 2016-17, with allocation of estimated budget recommended by Standing Committee held on 23rd Sept., 2016. The members of Advisory Committee recommended all the items No. 1-14 (Reference placed on Annexure.1) with few suggestions to incorporate in Plan of Action and to be organized as per the convenience and availability of the budget. The suggestions are as follows:
 - Prof. Sameen Fatima & Prof. Gulfishan Habeeb suggest to start short term courses on English proficiency, Hardware & Software Computer Trainings, along with other skill development courses. These courses will be beneficial for the betterment of the female students of MANUU. These courses can be conducted in collaboration with other agencies.

- Prof. Manju Chugani & Prof. Shahida suggested to offer Nursing and Para-medical courses separately for the girls of MANUU in future. It is also proposed to address the issues of PwD Women as a part of Outreach Programme.
 - An App can be developed to sensitize the society regarding gender equality in Urdu language.
 - Ms. Jameela Nishat, offered her collaboration in translation of books / booklets, written by Ms. Kamala Bhasin on different themes of 'Understanding Gender'. In addition to this, she suggested to approach Ms. Kalpana Kannabera (Director, CSD-Hyderabad) to contribute her writings on "**Women and Law**" along with Prof. Ahmedullah Khan, Dean, Faculty of Law, OU, in Urdu Language.
- 5) Dr. Shakeel Ahmad, Registrar, MANUU, advised to gear up the activities, as the plan period is going to end in March 2017. He suggested to collaborate with NGO(s) & departments of MANUU to organize different programmes in the campus.
- 6) The Director, CWS & Member, Convener, informed the members of Advisory Committee that, few initiatives already been taken up with NGO's and department of MANUU to conduct various activities in and out of the compass.
