Item 6.1: Confirmation and Approval of the minutes of 5th BoS meeting.



The minutes of 5th BoS were presented to the committee members and minutes were approved.

Item 6.3: Approval and Introduction in Increase of Credits (2 to 4) for SEC.

The issue of increasing the credits of Skill enhancement Course (SEC) from 2 to 4 credits was discussed by the members and members agreed and approved the credits of SEC to 4 credits. The external members suggested to keep hands on and demonstration session as part of SEC course to develop skills of the students.

Item 6.4: Approval and Introduction of Research ethics and Publication Paper.

The syllabus of Research ethics and Publication Paper as provided was presented in front of the committee members. As this course is made compulsory by UGC as part of PhD course were course work, it was resolved to adopt this paper in toto in Ph.D course work.

Item 6.5: Approval and Adoption of Syllabi template for B.Sc. Programmes.

Since the syllabus of regular and distance mode is common and at par for the Undergraduate courses and to bring equivalency in the distribution of syllabus required by DEB, the DE mode syllabus is divided in to four blocks. So, it is decided that one unit of regular mode syllabus is equal to one block of DE mode.

Item 5.6: Any other item with the permission of Chair.

Under this item, the external members recommended for the introduction of Master Programme in Physics as this one is missing from the physics section. In the light of New Education Policy also, Integrated Programme can also be introduced from next academic year. So all the members agreed upon and forwarded this request to the competent authority of the University for consideration and implementation.

At the end of the meeting Programme Coordinator, Physical Sciences. thanked the members for their inputs and suggestions on the various items discussed during the meeting.
