

MINUTES

Meeting of the Departmental Research Committee was held on 17th March, 2021 (3.00PM) to consider the following items.

Item No.1:

To approve the research supervisor to the eligible faculty members of DDE/Centres as per the University order no. MANUU/Acad/F.A15/2019-20/406, dated 13.03.2020.

Department of History has received applications from Dr. Tahseen Bilgrami, Dy. Director/Associate Professor, UGCHRDC, MANUU and Dr. Shaik Mahbaboob Basha, Assistant Professor, DDE, MANUU.

Resolution:

The Committee discussed the applications received from the two faculties Dr. Tahseen Bilgrami and Dr. Shaik Mahaboob Basha, and resolved as:

1. The committee found Dr. Tahseen Bilgrami ineligible for Ph.D. supervision. As per the Ph.D. regulations of MANUU2017. 13.7 *"A Research Supervisor, whose superannuation is due in two years, shall not be consider for appointment as Research Supervisor for new batch of research scholars"*, Her superannuation date as per the University record is 31.10.2022. Therefore, she does not fulfil the criteria of research supervisor as the remaining period of her service is less than two years.
2. The committee found that Dr. Shaik Mahbaboob Basha eligible for Ph.D. supervision as he fulfilled all the criteria for allocation of research supervisor as per the Ph.D. regulations of MANUU 2017.

Item No.2:

To discuss the irregularities of Ph.D. Scholar, Mr. Faheem Ahmad (A171797).

Resolution:


The committee discussed the case of Mr. Faheem Ahmad (A171797, 2017-18 academic session) and found that the last three RACs held on 30.04.2019, 25.09.2019 and 26.11.2019 was unsatisfactory. Despite several communications sent to him he has neither applied for the extension of Ph.D. nor contacted his research supervisor/Department. He has not even attended the last two RACs held in 2020. He was also served several memos and letters of warning in this regard. The last DRC held on 21.10.2020 had also taken a serious note of it.


DRC has recommended for the cancellation of Ph.D. registration of Mr. Faheem Ahmad (A171797) as per the Ph.D. regulations 19.3.1 *"Where the progress of the research work has been reported to be unsatisfactory in two consecutive Half-yearly progress reports or when two consecutive progress reports are not submitted"*.
