Minutes of the meeting of DRC held on 4th August, 2016

A meeting of DRC was held to discuss the following agenda:

1. Preparation of Urdu reading material.
2. Extension of a term for two Ph.D candidates
3. Extension of Scholarship (Non-Net) for Ph.D students for 4th year.
4. Extension for M.Phil students.
5. Any other.

Resolution:

After a thorough discussion, the committee has resolved to adopt the following recommendations:

1. The Dean, School of Arts and Social Sciences reiterated the fact than the dept. follow strictly the norms circulated earlier and adhere to the advice of the Hon' V.C in preparation of the reading material.
2. Mr. Bari Naik (Reg no. 1102010101. Date of reg. 8th August 2011) and Mr.Nisaruddin (Reg. no. 1102010104. Date of reg . 12th August 2011) scholars of Ph.D have submitted their plea to grant them an extension of 06 months. This is their first extension and the BoS, as per the regulation can sanction a year's extension on the recommendations of research supervisor, HoD and Dean. The candidates have submitted their final drafts which need corrections. Hence, the committee has recommended the Dean to sanction 6 months extension to both the scholars and place the matter before the BoS for approval/ratification.
3. Ms. Rasia Nayeem Hashmi is a Ph.D scholar receiving non-net fellowship for the last three and half years. After three years, on her request and as per the UGC's directive, that a Ph.D scholar is eligible to draw yet another year, the same scholarship, she claimed her non-NET fellowship in the fourth year for six months,

Now the academic section has advised to get the sanction because it is only after placing it before the DRC and after its approval alone she could be sanction the further installments based on her performance. Hence it is decided to recomend the release of the remaining installments, for the period if she continues her progress endorsed by the respective guide.

It is decided and recommended that the three students Naseema Khatoon, Uzma Afsheen, Sayeed-ur-Rahman persuing their M.Phil of 2014-15 batch may be recommended for extension on health ground and on the strong personal reasons. They already had taken one term extension which is completed on 11th July, 2016. Since the works are in advanced stage, the committee is of the opinion that their plea could be forwarded to the Honourable Vice-Chancellor along with their bound works for his perusal




