Items for Reporting

15.1. Confirmation of Minutes of 14th BOS meeting held on 24.08.2020.

The Chairman informed that minutes of 14th BOS were circulated among the members and since no comments were received hence minutes confirmed. **(Annexure-1)**

15.2. To report the change of paper codes of M. Tech. & MCA Syllabus due to iUMS restrictions/technical reasons.

The paper codes of M. Tech. & MCA Syllabus due to iUMS restrictions/technical reasons have been modified. **(Annexure-2)**

Items for Ratification

15.3. Confirmation of Minutes of 9th DRC & 10th DRC meeting held on 18.01.2021 & 14.12.2021 respectively.

The BOS confirmed and recommended for approval of the minutes of 9th DRC & 10th DRC meeting held on 18.01.2021 & 14.12.2021 respectively. **(Annexure-3 & Annexure-4)**

Items for Consideration

15.4. To consider the revision of the contents of the Syllabus Engineering Physics (BTCS102BST) & Engineering Physics Lab (BTCS150BSP) of B. Tech.(CS) Programme.

The BOS approved the contents of the Syllabus Engineering Physics (BTCS102BST) & Engineering Physics Lab (BTCS150BSP) of B. Tech.(CS) Programme. **(Annexure-5)**

15.5. To consider the revision by Department of English of the Syllabus English Communication LAB (BTCS260HSP) of B.Tech.(CS) Programme.

The BOS approves the revision suggested by Department of English for the Syllabus English Communication LAB (BTCS260HSP) of B.Tech.(CS) Programme. The revised syllabus **(Annexure-6)**

15.6. To approve the Panel of external examiners for B. Tech(CS)/MCA/M.Tech.(CS)/Other Programmes(Computer Science subjects).

The Panel of external examiners for B. Tech(CS)/MCA/M.Tech.(CS)/Other Programmes(Computer Science subjects) has been approved by BOS. However, in case of unavailability or denial by the examiner or due to any reason deemed necessary, HOD/Dean SOT may appoint an examiner not included in list & it shall be ratified in the subsequent BOS. **(Annexure-7)**

15.7. To introduce 4 credits Open Elective (Generic Electives) course titled "Introduction to Cyber Crime, Safety & Law" for Graduates & Post Graduates in all stream in view of the order MANUU/Acad/F.N.12/2021-22/113.

The BOS approved the introduction of 4 credits Open Elective (Generic Electives) course titled ***“Introduction to Cyber Crime, Safety & Law”*** for Graduates & Post Graduates in all stream in view of the order MANUU/Acad/F.N.12/2021-22/113. This course may be offered by the Department of CS & IT in any semester w.e.f. from academic year 2022-23; subject to availability of the minimum number of students and availability of the teaching faculty. **(Annexure-8)**

- 15.8. ***To introduce mandatory 3-credit Course for B.Tech(CS) Programme on “Universal Human Values 2: Understanding Harmony (UHV-II)” as steps for fulfilment of the aspirations articulated in NEP 2020 and as recommended by AICTE (F.No. AICTE/IPC/NCC-IP/2021-22). (Annexure-9)***

The BOS approved in principle, the introduction of mandatory 3-credit Course for B.Tech(CS) Programme on ***“Universal Human Values 2: Understanding Harmony (UHV-II)”*** as steps for fulfilment of the aspirations articulated in NEP 2020 and as recommended by AICTE (F.No. AICTE/IPC/NCC-IP/2021-22). However, as introduction of the above course requires a change in the overall structure of the B.Tech(CS) Programme, BOS deferred its implementation till a revised structure is proposed.

- 15.9. ***To consider the provision of supplementary examination for final semester students.***

All the members of the BOS has welcomed the provision of supplementary examination for final semester students only. The provisions of supplementary examination are available in various central/state/deemed Universities such as Jamia Millia Islamia, University of Hyderabad, IIT Madras, Jamia Hamdard etc. The following are the recommendations of the BOS:

The supplementary examination shall be held within two months from the date of declaration of the result of the regular examination. There shall not be any supplementary examination for internal marks. The supplementary examination shall be open to candidates who:

- (i) have been promoted to final semester.
- (ii) have appeared in final semester examination.
- (iii) have maintained the pre-requisite attendance and are not detained due to the shortage of attendance.
- (iv) have secured the passing marks in the internal examination in all the subjects.
- (v) have applied, filled the form and paid the requisite examination fee within the due date as notified by concerned authority.

There is no provision of supplementary examination for improvements.

- 15.10. ***To consider the admission of B. Tech(CS) lateral entry through entrance test.***

As all the admissions in the Department CS & IT academic Programmes are based on entrance test, the BOS has approved that

the admission of B. Tech(CS) lateral entry shall be through entrance test.

15.11. ***Any other agenda item with the permission of chair.***

Prof. Salman Abdul Moiz, External Member has proposed that, the Department shall start a deliberation to study and to incorporate the recommendations of NEP 2020 and Bloom's taxonomy in the curriculum.

The BOS has welcomed the proposal and recommended that a committee shall be constituted in this regard, to revise the structure/curriculum on the above line and submit a draft curriculum, preferably, to be implemented from academic year 2022-23.
