3. Reporting of shortage of Attendance and Non completion of course work and other criteria for the continuation of Ph. D program of Rubeena Begum (Batch 2022-23):-

Ms. Rubeena Begum (Enrollment No. A221431, Batch 2022-23) found irregular in completing the course work. As per the clause 14.11 of Ph.D Regulations, the candidate did not successfully complete the course work prescribed by the department during I Semester. She did not fulfilled attendance requirement nor appeared for Internal Assessment tests and semester examinations.

In this regard a notice served to Ms. Rubeena Begum, by mail (Dated April 10th, 2023) to report to the Department and submit the Justification of absence in person on or before 14-04-2023.

In reply of the notice, scholar sent a mail (Dated April 11th, 2023) for the information that, due to some severe health issues she could not attend the classes nor appeared for the Examinations. She did not submit any Medical reports as a proof of document in this regard.

After thorough discussions on the matter placed, the DRC members is in opinion that, if the candidate report immediately and submit the application to continue Ph.D Program, then the Department may give one more chance to complete the course work in II-Semester, subject to the fulfillment of the following items.

- 1. Fulfillment of 75% attendance requirement.
- 2. Fulfillment of Continuous evaluation process and internal assessment tests.
- **3.**Submission of authentic medical reports along with recovery report by the medical officer to continue the research work.

Further, DRC members discussed the case in view of clause 14.11 of Ph.D regulations and recommend that, "if the candidate failed to report and complete the mandatory criteria even in Semester-II of course work, she shall be declared as fail and her admission shall stand cancelled.

4. Cancellation of admission of Ghousia Sultana, (Ph.D scholar, Batch 2020-21):-

Dr. Shabana Kesar, Asst. Prof.DWE & Research supervisor, reported the Unsatisfactory progress of Ms. Ghousia Sultana and a request letter by the research scholar, for cancellation of admission .In this regard the supervisor submitted RAC recommendations (Dated 02-05-2023) and two consecutive unsatisfactory reports along with a copy of research scholar's letter for the approval of cancellation of admission. In view of two consecutive unsatisfactory progress reports, personal reasons mentioned in request letter by the research scholar and the RAC recommendations the members of DRC took decision and approved the cancellation of admission of Ms Ghousia Sultana, (Ph.D scholar, Batch 2020-21)

5. Approval for the revised title of research of Ms. Farheen Shama, Research scholar(Enroll No-A200299):-
