Terms and Conditions

- Only Potable water shall be supplied. The contract shall submit water quality certificate confirming to relevant IS Code before commencement of work and whenever source is changed or as required by department. The testing charges will be reimbursed if the results are found satisfactory.
- 2. Water shall be delivered to the MANUU Campus as & when required & at any time as directed by the designated officer within two (02) hours of intimation on phone.
- 3. The agency shall take all safety precautions to avoid all accidents. If any untowards incident/accident occurs during the period of work, the agency shall solely be responsible for the same and consequences thereof.
- 4. The payment shall be made as per actual quantity supplied & every fortnight on presentation of bills with delivery challan duly countersigned by the MANUU Officials.
- 5. The work shall be carried out in such a manner so as not to interfere / or adversely / or disturb the functioning of the University and other works being executed by other agencies, if any.
- 6. Any damage done by the contractor to any existing work or work being executed by other agencies shall be made good by him at his own cost.
- 7. The contractor shall maintain in good condition all work executed till the completion of entire work entrusted to the contract under this contract.
- 8. No payment shall be made to the contractor for damage caused by rain, flood and other natural calamities whatsoever during the execution of works and any damage to the work on this account shall have to be made good by the contractor at his own cost.
- The Contractor shall take instructions from the Incharge Engineering Section regarding collections and stacking of materials at site.
- 10. The Contractor shall be responsible to arrange at his own cost all necessary tools and tackles required for execution of the works including incidental original and maintenance works.
- 11. The operating cost of contractor's machinery at site i.e. Coolants/ lubricants/ Petrol/ Kerosene Oil/ Mobile Oil/ etc, if any shall be borne by the contractor himself.
- 12. The University shall not be responsible for any injury partial or permanent or death of any workers at site due to accident or malfunctioning of the equipment or by negligence of the Contractors staff on site.
- 13. All applicable and prevailing taxes will be recovered from the bills as applicable from time to time.
- 14. If any damage caused for public conveniences/ services, the same shall have to be repaired instant, failing which necessary recovery shall be make from the bill.
- 15. If any Building, Road and Channels will be damaged by the Contractor the same will have to repair by the Contractor at his risk and cost, otherwise the complete cost will be recovered as intimated by the Engineerin-charge.
- 16. Price should be inclusive of all (transportation up to MANUU, Gachibowli and all other incidental expenditure, if any).
- 17. Price of the items, GST% should be indicated separately.
- 18. No advance payment will be made.
- 19. Verbal quotation or incomplete quotation will be rejected.
- 20. Any variation in the specification(s) during repair/servicing will be rejected.

- 21. The repair and rectification work shall be carried out to make the equipment operational to the entire satisfaction of the Incharge Engineering Section.
- 22. Payment shall be made on submission of Invoice and as per actual quantity of water supplied.
- 23. The rates quoted are net and nothing extra shall be paid on any account.
- 24. The tax as applicable shall be deducted from the gross amount of the bill.
