Applicant is fail to attend the counselling on the scheduled date and time, your admission into ITI **will not be** considered, at later stage, under any circumstances. Selection will be based on "Merit-cum-Reservation" as per the rules in force. The university follows the Government of India norms for reservation of seats for admissions. Choice of the applicant will be considered as per seats available in each trade at the time of counselling.

Important Instructions:

Documents Required for Verification: Original documents with two sets of photo copies (S.No. 1 to 5) of each to be submitted at the time of counselling.

1. Pass mark sheet of 10th / SSC / equivalent board examination
2. Transfer certificate (from the institution last attended)
3. Bonafide / Conduct certificate (from the institution last attended)
4. Valid caste / category certificate (format prescribed by Government of India) if applicable
5. Aadhaar Card
6. Four passport size latest colour photographs of Candidate
7. One Photograph each of Parents/Guardian

Notes:

1. Call for counselling doesn't guarantee admission. Admission is subject to availability of seats in respective categories.
2. The original certificates of admitted candidates will be retained in the institute till the completion of the training period. Hence the candidates are advised to keep sufficient Xerox copies before submitting the original certificates:
3. He / She is allowed to bring their parents / guardian at the time of counselling for his / her guidance for selection of trade.
4. The selection and admission are purely provisional and liable for termination at any time during the training period in case, the information furnished or certificates submitted by the candidates are found incorrect / fake.
5. The decision of the Admission Committee of ITI-MANUU shall be final and bound to be applicable on the applicant.
6. No T.A & D.A is admissible for attending the counselling.
7. **Caution Money:** Candidates selected for admission to I.T.I shall have to pay **Rs. 60/- (Rs. Sixty Rupees only)** towards caution money deposit .
